Hawai'i Cannabis Organization Presenter Permission Release

This documents an agreement between Hawaii Cannabis Org (“Management”) and _____ (“Presenter”) regarding Hawaii Cannabis Awareness Conference June 15th and 16th, 2019 (the “Event”).

Management’s goal beyond this Event is to raise awareness for patients, caregivers and the entire Cannabis industry supply-chain in Hawaii to a wider global audience.

Management will record presentations during or related to the Event to be held June 15th and 16th, 2019.

This release (the “Release”) will serve as the Event’s agreement concerning your participation at the Event as a presenter. By agreeing to present you grant the Event, it’s organizers, Hawai’i Cannabis Organization, and other entities — the right to record, film and photograph your presentation at the Event, such recording hereafter referred to as the “Presentation”, and to distribute, broadcast or otherwise disseminate it, without any further approval from you, in whole or in part, throughout the world, in perpetuity, in any and all media now known or hereafter developed. This grant to the Event includes, but is not limited to, the right to edit the Presentation, and the right to use the Presentation either alone or together with supporting information, such as your name, voice, photograph, likeness and biographical data (collectively, “Supporting Information”). You agree that the Event or Hawai’i Cannabis Organization may designate others, e.g., distributors or broadcasters, to distribute the Presentation, and that these designees will have the same rights you’ve granted to Event organizers and Hawai’i Cannabis Organization, excluding editing rights. Hawai’i Cannabis Organization is interested in editing your presentation for formatting purposes.

Examples of permitted uses of the Presentation and Supporting Information include projecting the Presentation onto a screen during the Event, publishing on the Event website, Hawai’i Cannabis Organization’s websites; broadcasting the Presentation on television; and distributing the Presentation on external storage, mobile phones, films, and online video distribution channels, such as Facebook, Twitter, Google and YouTube.

Event and Hawai’i Cannabis Organization encourage intelligent public debate around each presentation. Accordingly, we distribute presentations under a “Creative Commons” license, which allows each distributed presentation to be re-published in non-commercial, non-derivative works, as long as appropriate credit is given and the presentation is not edited or distorted. By signing this Release, you acknowledge and agree that you do not object to Hawai’i Cannabis Organization distributing the Presentation under a Creative Commons license.

In addition, you understand and agree that: (i) Hawai’i Cannabis Organization isn’t obligated to use the Presentation or Supporting Information in any way; (ii) you won’t receive any form of payment in connection with the use of the Presentation and/or Supporting Information; and (iii) you may not revoke the rights granted in this Release. You affirm that: (i) you have the full power and authority to grant the rights and releases set forth in this Release; (ii) you are the sole author of the Presentation; (iii) you own all

rights to the Presentation, including, but not limited to, all copyrights and trademark rights; (iv) you will advise your Event organizer in writing of all third-party material contained in the Presentation (to which you have not secured all necessary rights); and (v) use of the Presentation as permitted by this Release will not violate the rights of any third party.

If any third party claims that the use of the Presentation violates its rights, you agree to cooperate fully with the Event organizer and/or Hawai'i Cannabis Organization to defend against or otherwise respond to such claim.

Presenter shall indemnify, defend and hold harmless the Event and its officers, directors, agents and other entities from and against claims, damages, losses and expenses, including but not limited to attorney's' fees, arising out of or resulting from the negligence or misconduct of Presenter in connection with performance of the work described in this Agreement.

This Release contains the entire understanding between you and the Event and Hawai'i Cannabis Organization regarding the Presentation and/or Supporting Information and may not be modified except in a writing signed by all parties.

This Release shall be governed by Hawai'i law without regard to choice-of-law principles. Any dispute concerning the Presentation and/or Supporting Information, or arising out of or relating to this Release, shall be resolved in the courts of the State of Hawai'i.

All Hawaii Cannabis Organization agreements are based on an element of trust and reasonable behavior.

The undersigned have read and agree to the terms and conditions stated above, certifies that he or she is an authorized representative of the "Presenter" and has the authority to bind "Presenter" to this Agreement, and acknowledges receipt of a copy of this Agreement.
